### **ABSENTEE BIDDING FORM**

Bukowskis handles absentee bids at its auctions free of charge against proof of identity, with full confidentiality. Our customer services will bid as favourably as possible on your behalf. You will receive a report in writing as soon as possible after the auction if your bid was successful. Bids are placed according to the specified lot number. In the event of any uncertainty concerning the lot, the catalogue number is decisive. An 18 % commission is added to the hammer price up to SEK 10 million. A 12 % commission is charged on the amount in excess of SEK 10 million. The commission is subject to VAT.

Lots covered by the Swedish copyright law (1960:729) are subject to a “droit de suite” fee – a resale fee to the artist. This fee is calculated on the hammer price according to the following percentage rates within each respective interval: 5 % up to EUR 50,000; 3 % on EUR 50,000.01-200,000; 1 % on EUR 200,000.01-350,000; 0.5 % on EUR 350,000.01-500,000; 0.25 % on amounts in excess of EUR 500,000. The maximum droit de suite fee is EUR 12,500. Lots subject to this fee are marked with a (d) in the catalogue or specified in a separate list provided at the viewing and auction.

### **PAYMENT AND COLLECTION**

Purchased lots must be paid and collected no later than eight working days after the final auction day at Arsenalsgatan 4. After eight days, uncollected lots will be moved to an external storage unit and interest on overdue payment and a storage fee of SEK 50 or SEK 100 will be charged per day and lot. Interest on overdue payment is charged in accordance with Swedish law. Bukowskis does not accept liability for any loss that may be incurred by the customer through Bukowskis' failure to purchase the lot in accordance with this absentee bidding assignment. Bukowskis is entitled to sell lots that have not been collected within three (3) months after the auction. For all other issues, please see the Conditions of Purchase.
